



Boone County Chamber Small Business Assistance Grant

The Boone County Chamber Small Business Assistance Grant is targeted at small businesses and nonprofits located within Boone County that have experienced financial stress in their operations due to COVID-19. Grant assistance is intended to provide interim relief to complement actions with your trusted financial institution, business interruption insurance, financial partners and state and federal programs offering assistance.

GENERAL TERMS AND CONDITIONS

- The value of each grant will be determined by the funds available, but will range between \$1,500 and \$3,000 for businesses and nonprofits impacted by the COVID-19.
- Targeted at businesses with 50 or fewer employees.
- Business must have been established prior to March 16th, 2020.
- Business must be in good standing (i.e. – no liens, judgements, etc.). Chamber membership is NOT required.
- Annual Revenues of the business or nonprofit not to exceed \$1 million as evidenced by Financial Statement or other financial documentation.
- Eligible uses include: working capital to support payroll expenses, employee sick leave, rent, mortgage payments, utility expenses, accounts payable or other similar expenses that occur in the ordinary course of operations.

***All grants awarded after 7/1/2020 will be noted in the city of Boone public record.**

The business or nonprofit must demonstrate financial stress or disrupted operations, which may include but are not limited to:

- Notices from tenants closing operations and not paying rent caused by loss of income.
 - Notice of inability to make loan payments due to reduced sales, suspended operations.
 - Increased cost related to COVID-19 prevention measures.
 - Notice of disrupted supply network leading to shortage of critical inventory or materials.
 - Other circumstances subject to review on a case by case basis.
- Funds **may not be used** to:
- Refinance debts incurred prior to the disaster event
 - Make payments on non-business loans
 - Pay tax penalties or non-tax criminal/civil fines
 - Repair physical damage, or
 - Pay dividends or other disbursements to owners or partners except as related to their performance of services for the business
