## **VENDOR INFORMATION**

You are invited to be a part of the first Pufferbilly Days™ Train Collectors Swap Meet on Saturday, August 6 and Sunday, August 7, 2022 in Boone, Iowa.

■ Location: Pufferbilly Days<sup>™</sup> is celebrated in the downtown business district of Boone. The Train Collectors Swap Meet will be located at the Boone County Fairgrounds Commercial Building, 1601 Industrial Park Road, Boone, IA 50036. Other festival activities will be taking place nearby, with food vendors located in the area to accommodate vendors and customers.

• Hours of Operation: Vendors may set up on Friday between 12-8 pm or Saturday starting at 7 am. Show hours are from 10:00 am to 4:00 pm on Saturday and 9:00 am to 3:00 pm on Sunday. Vendors MUST remain open for the duration of set hours. Vendors are responsible for putting up their own tables during setup, then cleaning up their area, returning their table, and vacating the building by 6:00 pm on Sunday.

• **Parking**: Parking is free and available immediately outside the Commercial Building on both hard and grass surfaces.

• **Booths:** Pricing is \$20 for one 10-foot by 10-foot booth space. Included in your registration is one 8-foot table OR two 6-foot tables. Table availability by size is limited, and tables will be allocated on a first-come, first-served basis during setup. Vendors are responsible for setting up and tearing down their own tables in the event space. Vendors are welcome to bring their own tables, shelving, and displays. Restrooms are available near the show area. The building is climate controlled.

• **Merchandise:** Vendors are prohibited from selling food and beverages. The Steering Committee reserves the right to disallow the selling or display of offensive/inappropriate material at their discretion.

• **Tax ID:** Vendors are expected to provide a valid Tax ID number on the application. Vendors must also comply with sales tax obligations and reporting requirements.

• **Deadlines: Priority registration must be postmarked by June 1, 2022.** Registrations postmarked after that date must include a \$25 late fee, totaling registration to \$45. No registrations will be accepted after July 15. An email confirmation with your booth assignment, map, and setup details will be sent to the email address listed on the form.

There are no refunds after your application has been selected for participation in the event. Register early - spaces are limited, and tables will go fast!
