All Market vendor booths will receive two (2) 3-Day Passes to enter the Windfest grounds and (1) 3-Day Parking Pass. **All additional entries will pay regular gate fees.** See Windfest Rules Governing Vendor Booths for dates and times of operation, as well as loading & unloading guidelines for set-up of your booth space. Be aware that the Festival goes on RAIN or SHINE. Windfest is an outdoor festival and is subject to conditions of weather or other acts of God. **No Refunds or Cancellations due to weather.** There are NO provisions for water or drainage outside. The Portland Chamber of Commerce or Windfest will not assume any responsibility for merchandise and/or displays. **Payment is non-refundable; no reimbursements to vendors will be honored.**
