## **WIGCOT Patrick J. Reinsma Scholarship Application**

- Applicants must be from the 19 counties defined as the Southwest Regional Tourism Specialist region as it was defined during Patrick's tenure: Adams, Columbia, Crawford, Dane, Dodge, Grant, Green, Green Lake, Iowa, Juneau, La Crosse, Lafayette, Marquette, Monroe, Richland, Rock, Sauk, Vernon, and Waushara.
- Must submit a letter of reference with contact information.
- Applications must be submitted by February 11, 2022, and will be announced by March 1, 2022.
