### **AGREEMENT and ENTRY RULES**

- 1) QUALIFIED ENTRIES: All homes entered are subject to inspection and approval by the Parade of Homes™ Committee. Failure to meet required entry conditions, participation rules and health and safety guidelines will result in disqualification and entry fees will not be refunded. Any builder who is disqualified may not be permitted to participate in the next Parade of Homes™.
- 2) PARADE HOME ENTRY FEES: By March 2<sup>nd</sup> GBVBA Member Entry Fees: 1<sup>st</sup> home \$995, 2<sup>nd</sup> home \$945 and \$895 for each home entry thereafter. Nonmembers: \$1300 per home entry.
- 3) LATE ENTRY FEES: After March 16th add \$100 per house entry. Homes entered after March 4th are not guaranteed placement in Insite Parade Guide. Entered after April 15th will not be guaranteed placement in The Eagle Parade Guide, on GBVBA Parade of Homes™ website or official Parade of Homes™ maps. Late Entries will be submitted to the Parade of Homes™ Committee for approval of entry.
- 4) DEPOSIT REQUIRED: A \$200 per entry deposit is required when picking up Official Parade of Homes™ yard signs and Parade Home Admission Tickets. The total entry fees are due in full no later than April 15<sup>th</sup>. Unpaid fees may result in your entry being removed from the Parade of Homes™. Deposits will be returned or applied to unpaid obligations within 35 days after the conclusion of the Parade of Homes™.
- 5) CANCELLATIONS AND REFUNDS: If ALL ENTRIES are cancelled before March 16<sup>th</sup> a refund less a \$300 publication fee will be due. Cancellations after March 16<sup>th</sup> will receive a refund less a 30% administrative fee. A replacement address for any entry will be accepted until April 15<sup>th</sup>. NO REFUND will be granted if cancellations are received after April 15<sup>th</sup>.
- 6) ENTRY INFORMATION: Each BUILDER entering a home must complete the attached form including name of company, street address of home being entered, subdivision name, city & county location, completion status, a description and square footage of home. The Builder Bio must be between 125-150 words. GBVBA reserves the right to edit or add text to meet the word count requirements.
- 7) VERIFICATION OF INFORMATION ON Parade of Homes™ WEBSITE & MOBILE APP: It will be the Builder or Builder's representative's responsibility to review their Parade of Homes™ entry information on the BCSparadeofhomes.org website and mobile app after notification from GBVBA. Written corrections must be submitted to the GBVBA office within 48 hours of such notification otherwise all information will be deemed as correct and approved.

- 8) ENTRY CRITERIA: All homes entered must include cabinets, trim, paint, tile, counter tops installed, electric, mechanical and plumbing trims and a working HVAC system with all health and safety measures in place. All homes entered must have a permanent sidewalk to the home. The exterior and interior of each Parade home must be clean, safe and clear of debris. ALL TRASH MUST BE REMOVED AND WALKWAY/DRIVEWAY POWER WASHED.
- 9) OFFICIAL PARADE YARD SIGN: All participating builders will be provided with an Official Red Parade of Homes™ sign. Builders may pick up and return their Official Red Parade of Homes™ signs at the BCSHBA office. Each sign not returned to GBVBA within 7 days after the Parade of Homes™ concludes will incur a \$100 fee taken from the deposit.
- 10) ENTRY STAFFING: All homes must be staffed during the hours of the Parade of Homes™ from 10:00 AM 6:00 PM on Saturday and 1:00 PM 6:00 PM on Sunday. This is required for your benefit and for the protection of your home and the public. No construction work can be performed during hours open to the public.
- 11)GENERAL PUBLIC TICKETS: Adults entering a Parade of Homes™ entry will be required to show a paper or digital receipt of the official Parade of Homes™ ticket. Builders and their representatives are responsible for and agree that there is a public admission fee to view all entries.
- 12)The term Parade of Homes™ is a registered trademark and may not be used by anyone not associated with the event or any home not officially entered into the Parade of Homes™.
- 13)LIMITATION OF LIABILITY: To the maximum extent permitted by applicable law, any builder entering a home in the Parade of Homes™ agrees to indemnify and hold BCSHBA/GBVBA, their officers, agents, employees and representatives harmless from any and all claims, damages, losses, causes of action, and liability of every kind, including legal expenses, court costs and fees and claims arising out of or in any way related to the subject matter of this agreement.

## Parade of Homes<sup>™</sup> Trademark Guidelines

As a licensee for use of the name Parade of Homes<sup>™</sup>, as registered with the State of Texas Secretary of State, the Bryan College Station Home Builders Association (BCSHBA) has the following duties and responsibilities.

The licensee shall have the responsibility of monitoring the usage of unauthorized parties of registered name "Parade of Homes™". Upon the discovery of an unauthorized usage, licensee shall notify the party, requesting that the party immediately cease and desist the usage of the registered name.

## Guidelines for Builder Entries in the Parade of Homes™

Only the home entries submitted and approved by the BCSHBA may be advertised or promoted as a Parade of Homes<sup>™</sup> participant. Advertisements that contain the Parade of Homes<sup>™</sup> title must contain the **Trademark symbol** <sup>™</sup> and only contain the addresses of the official Parade of Homes<sup>™</sup> entry. The Builder will place the red Parade of Homes<sup>™</sup> yard sign at the official home entry and may not use the sign for any other home not entered in the Parade of Homes<sup>™</sup>. The red yard sign(s) must be removed from display at the conclusion of the Parade of Homes<sup>™</sup> campaign.

## Guidelines for REALTORS® when advertising for Parade of Homes™ entries

Only the home entries submitted and approved by the BCSHBA may be advertised or promoted as a Parade of Homes<sup>™</sup> participant. Advertisements that contain the Parade of Homes<sup>™</sup> title must contain the **Trademark symbol** <sup>™</sup> and contain **only the addresses of the official Parade of Homes<sup>™</sup> entry**. No other homes may be advertised in the same advertisement using the Parade of Homes<sup>™</sup> title. The use of Parade of Homes<sup>™</sup> may not be used on any other signage and is strictly for use by the official home entry in the Parade of Homes<sup>™</sup>.

Failure to meet the above guidelines may result in legal action for unauthorized use of the registered trademark name of Parade of Homes™.
