

Dr. Starbird's research sits at the intersection of human-computer interaction and the emerging field of crisis informatics — i.e., the study of the how social media and other information-communication technologies are used during crisis events.

Currently, her work focuses on the production and spread of online rumors, misinformation, and disinformation during crises — including natural disasters, political disruptions, and a global pandemic. In particular, she investigates the participatory nature of online disinformation campaigns, exploring both top-down and bottom-up dynamics.

Dr. Starbird received her BS in Computer Science from Stanford (1997) and her PhD in Technology, Media, and Society from the University of Colorado (2012). She is a co-founder and current director of the UW Center for an Informed Public.

Lee McIntyre is a Research Fellow at the Center for Philosophy and History of Science at Boston University. Formerly Executive Director of the Institute for Quantitative Social Science at Harvard University, he previously taught philosophy at Colgate University, Boston University, Simmons University, Tufts Experimental College and Harvard Extension School, and was Associate Editor in the Research Department of the Federal Reserve Bank of Boston.

McIntyre is the bestselling author of POST-TRUTH -- which was named a CNN Book-of-the-Week in April 2018 and a Best Book of 2018 by the PBS News Hour — along with fourteen other works of fiction and nonfiction, including DARK AGES (2006), THE SCIENTIFIC ATTITUDE (2019), and his latest book HOW TO TALK TO A SCIENCE DENIER (2021), which was named one of the 32 Best Nonfiction Books of 2021 by the Next Book Idea Club. His work has been translated into thirteen languages.

McIntyre's popular essays have appeared in the *New York Times, Washington Post, Boston Globe, Baltimore Sun, Nature, Newsweek, Scientific American, The Chronicle of Higher Education,* and numerous other venues. He has appeared on CNN International on Amanpour and Company — and several other programs on PBS, NPR and the BBC — and has spoken at the United Nations, the Aspen Institute, and the Vatican.

DOWNLOAD THE 2022 ANNUAL MEETING MOBILE APP



Step 1: Download the App

Download the app from the Apple App Store or Google Play Store to the device you're bringing to the event. Scan the QR code or earch for keywords "assn for info science & tech".

Note: If you already have the 2021 app on your device, tap on Verify Account which should take you directly to the new event. If you are on the 2021 event, tap on three lines on the top left and then tap on the switch event which will take you to the event directory page where you will see the 2022 event.

Step 2: Verify Your Account

Using the device you intend to use for the meeting, check for an email from Crowd Compass and click Verify Account to unlock all the features of the app.

Step 3: Set up Your Profile

To enhance your networking opportunities at the meeting, we encourage you to set up your profile and include a photo and brief bio as soon as possible. Be sure to toggle the "Hidden" option to ensure your colleagues can find you!
