SAFEGUARDING KNOWLEDGE: DISASTER MANAGEMENT IN INDIAN ACADEMIC LIBRARIES

In an era defined by technological advancements, Indian academic libraries leverage cutting-edge solutions to enhance disaster preparedness. Digitization initiatives ensure that valuable collections are backed up, reducing the risk of loss. Additionally, sophisticated library management software aids in cataloging and tracking resources, facilitating efficient disaster recovery. The success of disaster management strategies relies on the preparedness of library staff. Indian academic libraries invest in training programs, conducting drills, and fostering a culture of awareness. Collaborative efforts with local communities ensure a coordinated response in times of crises. Acknowledging the pivotal role of academic libraries in preserving knowledge, the Indian government has initiated schemes to support disaster-resilient infrastructure. Financial incentives and guidelines encourage libraries to adopt state-of-the-art technologies and best practices in disaster management.

Digital policy is a broad term encompassing the political decisions and frameworks surrounding digital technologies and their impact. It is an <u>independent policy</u> that deals with how governments, institutions, and organizations establish rules and guidelines for navigating the opportunities and challenges the digital world presents. The Government Offices of Sweden argue that digital policy is crucial in determining governmental/organizational activities regulating digital and electronic communications, network and information security, access, and digital infrastructure are fully in place against cyber threats and freedom of expression, access to information and diverse cultural content, <u>health and well-being</u> are protected (<u>UNESCO</u>).

Digital Policy, Capacities and Inclusion



<u>UNESCO</u> has highlighted that digital innovation in AI is growing rapidly and has the potential to help achieve gender equality, disability rights, and social inclusion (<u>GEDSI</u>; Umboh, et., al 2023).) and contribute to the attainment of Sustainable Development Goals (<u>SDGs</u>; <u>ITU</u>). However, while AI can be beneficial, users must exercise caution and be mindful of pressing concerns related to human rights, ethics, and knowledge sharing.

Another crucial GEDSI framework that demands our attention centers around <u>Governance</u>, <u>Education</u>, <u>Democracy</u>, <u>Security</u>, and <u>Innovation</u>. Understanding the GEDSI principles is essential to establishing comprehensive data privacy policies that give individuals control over their personal information is a must.

Website Privacy Policy/Governance

Managing your legal obligations, including privacy obligations, is essential when you operate an online business. A well-drafted privacy policy is critical if your business collects personal information. Personal information is defined as anything that can identify (or reasonably identify) an individual, such as name, email address, phone number, home address, and bank details—or if your business has an annual turnover of over \$3 million (<u>auDA</u>).

Data Protection and Privacy Legislation Worldwide

'The <u>UNCTAD Global Cyberlaw</u> <u>Tracker</u> is the first-ever global mapping of cyber laws. It tracks e-commerce legislation in e-transactions, consumer protection, data protection/privacy and cybercrime adoption in the 194 UNCTAD member states. It indicates whether or not a given country has adopted legislation or a draft law pending adoption. In some instances where information about a country's legislation adoption was not readily available, 'no data' is indicated.
