Your business plan is the foundation of your business. It's a roadmap for how to structure, run, and grow your new business. ☐ Fund your business

Your business plan will help you figure out how much money you'll need to start your business. If you don't have that amount on hand, you'll need to either raise or borrow the capital. ☐ Choose a business structure

☐ Register your business

Once you've picked the perfect business name, it's time to make it legal and protect your brand. If you're doing business under a name different than your own, you'll need to register with the federal government, and the state of Missouri too. Once you've successfully completed this step you will receive your employer identification number (EIN). You'll use your EIN for important steps to start and grow your business, like opening a bank account and paying taxes. It's like a social security number for your business.
