



## 2024 NARI Cares Scholarship Application

NARI Cares Minnesota is pleased to announce that \$1,000 scholarships will be offered to three 2024 graduates from area MN High Schools. The scholarships will be awarded in \$500 increments renewable for two semesters.

### Criteria

- \*Resident of Minnesota
- \*Student must be pursuing a post-secondary education at either a two-year or four-year educational or vocational institution relating to the field of construction or related trades in the Summer or Fall of 2024.
- \*NARI MN members should note that at least one scholarship may be awarded to a NARI MN member's child

### Selection Process

Applications will be reviewed, and a decision will be made no later than April 15th, 2024

Students will be selected based on the following:

- \*Response to the essay question below
- \*Participation and leadership in school and community activities and work experience.
- \*Personal circumstances relating to need, this may include your Expected Family Contribution as indicated on your FAFSA, and Academic achievement
